History

Jahan University Legal Clinic was established in 2016 in order to improve the professional knowledge and acquire practical legal skills of the students of Sharia and Law faculties with the financial support of Jahan University, as a clinical canter at the university level within the framework of said courses. After obtaining an official license from the independent board of legal assistance of the Ministry of Justice, this clinic has been working in the professional skills training departments of the criminal and civil enforcement system "lawyer, police, attorney general, courts, justice and law" for The students of Sharia and law faculties, providing free legal aid for the poor, women and children and public legal awareness for teachers and students of schools have provided valuable services that annually more than 300 students, teachers, Educators, disadvantaged and poor people have benefited from these programs.

Since starting the of the legal clinic of Jahan University, it has established close relation with other national and international organization for its smoot running, including ILF-A, USAID and other organization and in this regards we have receive many grants from different donors in field of legal aids, access to justice, rule of law, and legal advisory.

From 2016 up to now Jahan University Legal Clinic has graduated ten rounds of student who are currently working in justice and judicial institutions of the country and currently also this clinic has around hundreds students who are receiving clinical service in field of rule of law, access to justice, legal advisory, legal aids and other related topics.

Basic goals of Jahan Legal Clinic


- 1. Raising the level of knowledge, ability and teaching skills of students,
- 2. Informing different sections of the society, especially the range of teachers and students, about their basic rights,
- 3. Providing legal awareness for different people of the society in terms of laws, legal references to solve problems, dilemmas and the process of the trial system in the country's judicial and judicial institutions,
- 4. Having an ideal society free from any kind of discrimination and oppression,
- 5. All members of the society have access to a fair trial and enjoy their rights,
- 6. Establishing national unity and resolving any kind of dispute and conflict,
- 7. Trying to promote the rule of law and respect for it in the society,
- 8. Providing free legal assistance for the poor, especially women and children,

9. Creating a practical, legal educational program, similar to the curricula of Herat University's Law and Shari'ah courses, for students to improve their professional skills, preparing students for judicial and judicial positions.

Legal Clinic Duties:

- 1. Arranging the weekly, quarterly and annual work plan of the Lega Clinic to achieve the set goals.
- 2. Conducting training programs in civil cases theoretically and practically under the supervision of professors and defense lawyers.
- 3. Conducting theoretical and practical training programs in criminal cases under the supervision of professors and defense lawyers.
- 4. Conducting training programs for specialized skills of child justice in correctional centers and local councils.
- 5. Organizing educational workshops different sections of for the society level the schools and other localities public of for awareness.
- 6. Organizing forensic medicine workshops for students about the role of forensic medicine in the process of criminal and civil proceedings.
- 7. Organizing workshops on the principles of legal justice in criminal and civil cases in Afghanistan.
- 8. Legal awareness for village lords and councils, restricted children, parents of restricted children and orphanages.
- 9. Conducting mock trials by legal clinic employees and doing field work in judicial offices.
- 10. Creating coordination with iudicial and iustice departments to advance practical and research activities students the of and graduates.
- 11. Providing monthly, quarterly, annual and when necessary reports from the relevant department to achieve the goals.
- 12. Implementation of other duties assigned to him by the relevant manager according to the laws, regulations, and objectives of the department.
